#### 1. Minutes

a. The minutes of the Board of Directors of the August 27, 2019 were reviewed. The minutes were then approved by motion made, seconded, and passed unanimously.

# 2. Presidents Report:

a. Mr. Rawls reported on a matter raised by a homeowner and their concerns regarding the practice by the HOA in charging new homeowners a transfer fee at the time of sale. He and the directors discussed this at length and concluded it would be prudent to engage outside counsel to review and advise the HOA on this matter and its current practice. He then made the motion to instruct and authorize the secretary to engage Burns Law to review this matter on behalf of the HOA.

After discussion, the recommendation was approved by motion made, seconded, and passed unanimously

### 3. Financial

a. Mr. Ellis reviewed with the board both the August financial statements for the Association. He rnoted the income for the month was limited to \$8.00 of interest income which was offset by over \$1,300 of expenses related to the annual insurance premium payment. Lastly he pointed out the premium paid in August excluded \$50.00 of broker commission which would be paid in September.

After discussion, the financial report was approved by motion made, seconded, and passed unanimously.

#### 4. Committee Reports

#### a. Architectural Committee: (Ron S.)

Mr. Surber, in his final report as ACC chair, reviewed with the committee the status of 6 homeowners that had recieved letters noting ACC infractions. He noted that 3 of the 6 had addressed their respective violations and taken appropriate corrective action. The remaining 3 homes still needed to make the appropriate corrections. These violations included parking of vehicles on lawn area beside the home without appropriate fencing, garbage and yard waste bins visible from the street, and lastly yard and fence needing maintenance. He described how each of these 3 homeowners had received letters requesting action be taken to address their specific violations and this action to be done on or before September 25th.

Lastly Mr. Surber noted that after several years of service as both a HOA Officer and chairing the ACC committee he would resigning effective September 20th. The officers and Directors expressed their sincere appreciation to Mr. Surber for his tireless efforts and years of dedicated service to the HOA and the efforts to maintain and improve our neigborhood. They noted that his involvement and service would be missed and thanked him for all he has done for the Association
